

## **“Craft your Escape with Kirk and Sweeney”, CONTEST RULES AND REGULATIONS**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

**1. Eligibility:** Recipe Contest (the “Recipe Contest”) is open only to those who sign up at the online recipe contest page and who are 21 years old as of the date of entry.
